DESCRIPTION (field, expectations, comments, requirements):

From a candidate for the position of assistant is required to:

- 1) at least a Master of Science in Engineering degree in the field of natural sciences or a related field, in the discipline of environmental engineering, mining, and energy or a related field,
- 2) knowledge of geophysical methods used to investigate geological structures on both regional and local scales, particularly seismic and electromagnetic methods, supported by publications and completed projects,
- 3) experience in exploration and engineering geophysics as well as petroleum geology, particularly in the design and acquisition of seismic and electromagnetic data, confirmed by participation in projects or relevant certificates/trainings,
- 4) experience in seismic data processing confirmed by participation in projects or relevant certificates/trainings,
- 5) experience in teaching,
- 6) proficiency in SeisSpace (Halliburton) seismic data processing software and other specialized programs,
- 7) documented scientific achievements, such as participation in scientific conferences and authorship/co-authorship of national and international scientific publications in the specialist areas specified in points 2, 3, and 4,
- 8) documented knowledge of English at least at B-2 level,
- 9) proficiency in the Polish language is required (non-Polish citizens should provide a certificate of proficiency in Polish at a minimum level of C1).

**Additional factors that will positively influence candidate evaluation:**

- 1) experience in the industry (oil sector, geophysical companies),
- 2) experience in managing research projects related to seismic and electromagnetic data processing and interpretation, confirmed by project participation or relevant certificates/trainings,
- 3) possession of geological qualifications in category IX.

**To be considered a candidate you must meet the following requirements set out in the Act:**

- 1) you hold the qualifications defined in the Act,
- 2) you have full capacity for juridical acts,
- 3) you have not been convicted for an intentional offence,
- 4) you enjoy full public rights.

## DOCUMENTS REQUIRED

- 2) copy of Master's diploma,
- 3) information on previous scientific and teaching activities,
- 4) list of publications,
- 5) documents confirming knowledge of English at a minimum B2 level,
- 6) certificates confirming knowledge of relevant software,
- 7) certificate of Polish language proficiency at a minimum C1 level (for non-Polish citizens),
- 8) description of the candidate's scientific plans.
