- 1) doctoral degree in Chemistry,
- 2) at least 7 years of experience in conducting research in the field of environmental catalysis (ability to use mass spectrometry, gas chromatography, FT-IR and UV-vis spectroscopy and the temperature-programmed reduction and oxidation method),
- 3) experience in the synthesis of catalysts and catalyst supports (including highly porous materials),
- 4) ability to plan and conduct experiments,
- 5) experience in implementing and managing research projects – lead researcher of at least one scientific project (national or international),
- 6) participation in at least two scientific internships (minimum one month each) at foreign scientific institutions.
- 7) scientific publications in the field of catalysis in international journals from the JCR list (minimum 15),
- 8) cumulative Impact Factor (IF) of scientific publications not less than 80,
- 9) active participation in national and international scientific conferences (including at least 2 oral presentations),
- 10) at least 5 years of experience in teaching (laboratories, seminars, and workshops), including chemical technology and catalysis,
- 11) supervision of master's and bachelor's/engineer's theses,
- 12) experience in supervising international students,
- 13) documented organizational activity in scientific conferences/seminars,
- 14) english language proficiency at a minimum C1 level,
- 15) polish language proficiency at a minimum C1 level in the case of foreigners,
- 16) exemplary ethical conduct (in accordance with www.agh.edu.pl-Dokumenty-"Kodeks Etyczny"),
- 17) other scientific achievements and organizational experience.

A person may become a candidate if they meet the following requirements set forth in the Law on Higher Education:

- 1) has the qualifications specified in the Law,

- 8) confirmations of participation and presentation format at international conferences,
- 9) document confirming teaching experience, including information on the type, number of hours, and form of conducted didactic classes,
- 10) document confirming the function of supervisor of master's and bachelor's/engineer's theses,
- 11) list of scientific achievements.
