The candidate should have scientific achievements in the field of thermochemical research of solid fuel conversion processes, in particular the gasification process, documented in the form of publications in journals from the Journal Citation Reports (JCR) list. The candidate should have knowledge in the above-mentioned areas and experience in researching the properties of solid fuels, with particular emphasis on waste and biomass. In addition, the candidate should have experience in teaching, including conducting laboratory classes. Additionally, the candidate should have good English skill at a level that allows for publication in English. A willingness to pursue further scientific development and the ability to solve problems are also required.

Requirements:

- 1) holding a PhD in the scientific field of Engineering and Technology, in the scientific discipline of chemical engineering:
- 2) documented scientific achievements in publications in journals listed in the Journal Citation Reports (JCR) in the field of thermochemical conversion processes of solid fuels;
- 3) experience in laboratory work, with particular emphasis on methods for assessing solid fuels and their conversion;
- 4) documented knowledge of English, at least at level B-2, as defined by the Council of Europe's Common European Framework of Reference for Languages;
- 5) advanced knowledge of MS Office (Word, Excel, PowerPoint) as well as Orgin and Statistica software;
- 6) certificate of completed teacher training;
- 7) proven ability for research and teaching;
- 8) organizational and teaching achievements;
- 9) active participation in conferences and symposia.
