### II) Job Offer description

The Institute of Oriental Studies at Adam Mickiewicz University in Poznań announces a competition for the position of lecturer (three-quarter time) in the discipline of linguistics. The position is intended for a candidate with experience in teaching the Tamil language and conducting linguistic research on Dravidian languages. Emphasis will also be placed on the candidate's future career path, including the prospect of academic advancement.

### III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2024, item 1571, Article 113 as amended) and who meet the following requirements:

- 1. A master's degree in the discipline of linguistics.
- 2. several years of teaching experience (Tamil language didactics),
- 3. good knowledge of written and spoken English, Tamil and hindi;
- 4. educational background for teaching subjects introduction to linguistics will be an additional asset;
- 5. In addition, a strong prospect of obtaining a doctoral degree in the humanities, in the discipline of linguistics, within the next 1–2 years is highly desirable.

- 5. Very good substantive preparation for teaching Tamil as a foreign language 10 points
- 6. substantive preparation for teaching introductory linbuistics course will be an additional asset 3 points
- 7. Documentation of other achievements relevant to the research field and the employment profile 3 points
- 8. Verification of the candidate's individual academic development plans 6 points
- 9. Job interview. 10 points

## VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.

7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
