A doctoral degree in the field of social sciences, in one of the following disciplines: sociology, sociological sciences, cognitive science, or psychology. In the case of holding a doctoral degree in a discipline other than sociology or sociological sciences, a master’s degree in sociology or sociological sciences is required. 2. Documented publication activity, including scientific articles in journals listed by the Polish Ministry of Science and Higher Education (MNiSW), including publications in English in the years 2020–2025. Additional advantages include at least four publications with a score of no less than 40 points, as well as evidence of at least two single-authored

Documented experience in applying for research grants funded from external sources (e.g., NCN, Norwegian funds, EU funds, Horizon 2020), as well as leading or participating in research grants and/or scientific research projects. 4. Documented experience in conducting quantitative social research and statistical analysis. 5. Documented active participation in conferences or in the organization/co-organization of scientific conferences. 6. Documented academic teaching experience in the years 2020–2025, including at least 210 teaching hours in sociology courses, of which at least 90 hours must involve courses related to conducting and analyzing quantitative research. 7. A declaration of readiness to conduct lectures and other teaching activities in English in subjects offered within the sociology program. 8. Documented professional development in teaching and/or research within the last five years. 9. Fluent command of the Polish language, spoken and written. 10. Knowledge of one of the conference languages.

Formal evaluation of submitted proposals. 3. Call to provide additional or missing documents if necessary. 4. Selection of candidates for the interview stage. 5. Interviews for candidates who meet the formal requirements. 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation. 7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
