A doctoral degree in the humanities in the field of cultural studies or cultural and religious studies. 3. Documented experience in teaching at a higher education institution. 4. Willingness and ability to undertake research and teaching in the discipline of cultural and religious studies, with particular emphasis on cultural studies methodology and cultural animation issues. 5. Willingness to teach in English. 6. Documented participation in academic life, e.g., conference presentations, foreign internships, and research projects, in proportion to the level of career advancement. 7. Documented experience in collaboration, e.g., with research institutions, cultural institutions, or non-governmental organizations specializing in cultural animation activities. 8. Achievements documented by scientific publications – in a number proportional to the level of career advancement. 9. Candidates are asked to attach one sample scientific publication (no larger than approximately one publishing sheet). 10. The main criterion for candidate selection is scientific achievements.

Scientific achievements, in particular publications, participation in prestigious scientific conferences, and participation in grants and/or research projects. 3. Teaching experience at the academic level.
<p>VIII. The selection process</p>	<ol style="list-style-type: none"> 1. Competition committee begins working no later than 14 days after the deadline for submission of documents. 2. Formal evaluation of submitted proposals. 3. Call to provide additional or missing documents if necessary. 4. Selection of candidates for the interview stage. 5. Interviews for candidates who meet the formal requirements. 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.

IX. Prospects for professional development

7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
