DESCRIPTION: the contest concerns the position of assistant for teaching at the Faculty of Health Sciences and Physical Education. The candidate should have a master in dietetics. Have competences to teach subjects including: food and dishes technology and commodity science, phytotherapy/biodiversity and nutrition in various diseases.

It is assumed that there can be an interview with the candidates.

Candidates applying for employment as assistant for research and teaching should meet the conditions set out in the Act of 20 July 2018 Law on Higher Education (Journal of Laws of 2022, item 574, as amended) and in the Statute of the Kazimierz Wielki University in Bydgoszcz and meet the following requirements:

1. Have a master's degree in dietetics or food technology with a specialization in human nutrition.
2. Have experience in dietary counseling (dietary office).
3. Have academic and didactic experience.
4. Have knowledge of English at least at B2 level.

5. The foreign candidate is required to have documented knowledge of the Polish language at an advanced level (C1).

The following will be considered as additional advantages of the candidate:

1. Postgraduate studies in clinical nutrition.
2. Other documented activities/experience in pediatric nutrition, bariatric nutrition, and phytotherapy.

REQUIRED DOCUMENTS:

A candidate applying for the position of assistant for research and teaching is obliged to submit the following documents:

1. Application addressed to the Rector.
2. CV and cover letter.
3. Personal questionnaire, attached as Appendix 1 to ordinance. 43/2018/2019 of the Rector of the Kazimierz Wielki University of June 14, 2019.
4. Photo.
5. Document confirming obtaining a professional title, additional education.
6. Copies of employment certificates from terminated employment relationships.
7. Declaration that in the event of employment, the Kazimierz Wielki University will be the primary place of work of an academic teacher, on the template constituting Appendix 2 to the ordinance no. 43/2018/2019 of the Rector of the Kazimierz Wielki University of June 14, 2019.
8. Documents confirming the fulfilment of the additional requirements specified in the competition announcement.
9. Statement on meeting the requirements of art. 113 of the Act of July 20, 2019. The Law on Higher Education and Science, on the template constituting Appendix 3 to ordinance no. 43/2018/2019 of the Rector of the Kazimierz Wielki University of June 14, 2019.
10. Declaration of awareness of criminal liability related to certifying untruths (Article 233 of the Penal Code) on the template constituting Appendix 4 to the ordinance no. 43/2018/2019 of the Rector of the Kazimierz Wielki University of June 14, 2019.

All documents should be prepared or translated into Polish.

Documents confirming obtaining a professional title, academic degree, academic title or equivalent, obtained abroad, should meet the equivalence requirements specified in art. 326, art. 327 or article. 328 of the Act of 20 July 2018 Law on Higher Education and Science, in particular, at the time of submitting the documents, the candidate's nostrification procedure should be completed.

Documents submitted or sent after the submission deadline will not be considered. The date of the postmark determines the validity of the sending.

The University reserves the right not to settle the competition without giving a reason. The result of the competition is not tantamount to employment of the candidate, but is only a recommendation for the Rector. The final decision on employment is made by the Rector.
