Significant research achievements in Greek and Coptic papyrology, documented by publications in renowned international academic journals. 4. Experience in editing, studying, and interpreting Greek papyri, as well as expertise in textual criticism and philological analysis of unpublished Greek and Coptic literary sources. 5. Significant research experience gained after obtaining a doctoral degree, particularly at recognized international research institutions. 6. Experience of implementing and leading national and international research projects. 7. Fluency in spoken and written Polish, enabling independent performance of duties related to the position, particularly communication with the administration of the University of Warsaw and participation in the unit's organizational activities.
