The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2021, item 478, i.e. Article 113) and who meet the following requirements:

1. The candidate should have the professional title of Master of Physical Education or its equivalent.
2. The candidate should have a minimum of 5 years of experience as a physical education teacher.
3. It is advisable to have many years of experience in conducting group and individual classes.
4. The candidate should have extensive experience in teaching football or futsal (with particular emphasis on female football or futsal).
5. The candidate should have qualifications in conducting basketball classes.

6. The candidate should have the ability to conduct classes in English.
7. The candidate should be ready to improve his professional qualifications.
8. The candidate should have the rights of a camp counselor.
9. The candidate should be available.
10. Experience in the national team is welcome.
11. Experience in the Polish Academic Championships is welcome.
12. Organizational and sports experience in a sports club, with particular emphasis on AZS, is welcome.

VIII) The selection process

1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.
4. Selection of candidates for the interview stage.

5. Interviews for candidates who meet the formal requirements.
6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
