

Competition for the position of the Lecturer

Rector-Commandant of the General Tadeusz Kościuszko Military University of Land Forces (MULF) announces a competition for position of Lecturer at the Faculty of Security Studies, MULF, in the group of teaching employees.

Job status: full, job agreement from October 2021

<u>Place of work:</u> The General Tadeusz Kościuszko Military University of Land Forces, ul. Piotra Czajkowskiego 109 Wrocław, Poland.

Main duties will include:

- 1) Teaching students in accordance with their study plans, curricula and timetable in the number specified in the applicable resolution of MULF's Senate;
- 2) Participation in various forms of education as well as preparation and implementation of course assessment tutorials and consultation:
- 3) Participation in the preparation and conduct of diploma exams;
- 4) Cooperation with other employees at the University in developing and updating study plans and curricula as part of subjects implemented;
- 5) Improving teaching and methodological qualifications;
- 6) Participation in the work of committees appointed at the University level to support its activities;
- 7) Participation in the work of teaching commissions in the recruitment process the University;
- 8) Preparation and maintaining of the required didactic and methodological documentation in accordance with applicable standards;
- 9) Performing other duties as required by superiors, related substantively to the position held.

Requirements related to the job that must be met:

- 1) Having a master, master of science or equivalent degree completed in the mathematics as a field of study;
- 2) Declaration of full-time employment at AWL as the primary place of work;
- 3) Availability, communication skills, responsibility and self-reliance;
- 4) Having a substantive competences in conducting classes with university students in the higher mathematics and the applied mathematics, especially in the probabilistic methods and the mathematical statistics;
- 5) Declaration of participation in organizational projects implemented at MULF.

Additional competences:

- 1) Professional experience in conducting mathematics classes with IT methods, e.g. collaborative software, educational technology and mathematics software packages;
- 2) Competences in conducting lectures in the higher mathematics and the applied mathematics, e.g. having a scientific degree in the field of the exact and natural sciences and in the discipline of mathematics, professional experience in the application of mathematics, scientific achievements;
- 3) Engagement and creativity conditioning the attractive course of classes;
- 4) Ability to work in task teams.

- in the case of candidacy of foreigners whose documents are not issued in Polish, it is necessary to submit copies of the documents together with a sworn translation;
- if the title / academic degree was obtained at a foreign university, a copy of the document confirming the nostrification of the title / academic degree should be submitted (if required by law) or a statement as to the basis for the recognition of the title / degree on the basis of the agreement on recognition of equivalent education in Poland;
- for candidates who are not Polish citizens a declaration about undergoing the examination procedure is required.

The above documents should be delivered to MULF in a sealed envelope with the name of the position.
