**THE RECTOR  
of the Jagiellonian University  
announces a call for the position  
of POSTDOCTORAL RESEARCHER  
in a group of researchers**

at the Faculty of Philosophy  
**in the field of psychology**

The call is open to persons who meet the conditions set out in Article 113, 116 s 2 item 3 of the Act of 20 July 2018 — the Law on Higher Education and Science and, pursuant to Article 165 of the Statute of the Jagiellonian University, meet the following qualification criteria:

- 1) hold at minimum a doctoral degree,
- 2) have relevant scientific achievements,
- 3) take an active part in scientific life.

**Ideally, the candidate should meet the following criteria:**

1. is a scientist with a doctoral degree in the field of psychology or related sciences (e.g. medicine), cooperating with PRAs ([https://futuresoc.id.uj.edu.pl/en\\_GB/about-us](https://futuresoc.id.uj.edu.pl/en_GB/about-us)),
2. has international experience (before or after obtaining a doctoral degree), in particular, was a student, doctoral candidate or researcher at a foreign university, at a foreign research institute, foreign research center, international research institute or other foreign science institution,
3. is the main author of at least two publications published in journals included in the Journal Citation Index database,
4. has experience in organizational and design work, in particular in the implementation of projects financed from external sources, e.g. is / has been a project manager, main contractor or co-contractor of at least one research grant obtained from external sources,
5. is fluent in English,
6. has conducted documented cooperation in a recognizable, international research network,
7. has experience in popularizing science or cooperating within the socio-economic environment.

**Expectations:**

1. implementation of the research project in accordance with the adopted goals,
2. submission of at minimum one publication to high-scoring journals (minimum 140 points) from the list of the Ministry of Education and Science (<https://listymnisw.pl/full.php>),
3. submission of a research grant to an external institution,
4. cooperation in the creation of the Jagiellonian Center for Psychotherapy (JCP), an inter-faculty unit focused on researching the effectiveness of psychotherapy and other psychological interventions,
5. active contribution to activities under the Excellence Initiative — Research University program, under the Priority Research Area of the Society of the Future, and under the Brain and Behaviour Lab,
6. representing the University externally and popularizing science, in particular the research conducted within the Excellence Initiative — Research University program.

**We offer:**

1. The offered remuneration includes base salary and an allowance.
2. A fixed-term employment contract of 30 months.
3. Individual research grant (PLN 100,000) and the opportunity to participate in the competition for funding from the seed grants fund.

The candidate will receive an individual research grant under which they will implement the project: *Interdisciplinary research on the effectiveness and healing factors in psychotherapy and other psychological interventions*. The project should concern interdisciplinary research on the effectiveness and healing factors in psychotherapy and other psychological interventions. The proposed research should follow the 4I principle represented in the Initiative of Excellence — Research University program, i.e. be interdisciplinary, innovative, contribute to internationalization and integration with the external environment. The project should clearly indicate the following: the relationship with the research topic indicated in the call, the project objectives, the research methodology and work schedule, the planned project results, the forms of dissemination of results (including cooperation within the socio-economic environment), the project's importance for the areas of interest of the Brain and Behaviour Lab and FutureSoc PRA ([https://futuresoc.id.uj.edu.pl/en\\_GB/bbl](https://futuresoc.id.uj.edu.pl/en_GB/bbl)), as well as a bibliography. In addition, the candidate will have the opportunity to participate in the competition for funds from the 'seed grants' fund for research groups emerging under the Brain and Behaviour Lab, on the terms and in the amount provided for in the fund statute and bylaws.

9. a research project (a project description of up to 5 standard pages with a bibliography) in English,
10. a completed personal information form concerning the applicant,
11. a declaration that the Jagiellonian University will be the primary place of work in the event of the candidate being employed,
12. a representation pursuant to Article 113 of the Law on Higher Education and Science,
13. a declaration of the knowledge and acceptance of the principles of intellectual property management and the principles of commercialization of the Jagiellonian University,
14. information on the processing of personal data.

### Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the attached advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the attached advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
