**THE RECTOR
of the Jagiellonian University
announces a call for the position
of POSTDOCTORAL RESEARCHER
in a group of researchers**

at the Faculty of Philosophy
in the field of sociological sciences (or related)

The call is open to persons who meet the conditions set out in Article 113, 116 s 2 item 3 of the Act of 20 July 2018 — the Law on Higher Education and Science and, pursuant to Article 165 of the Statute of the Jagiellonian University, meet the following qualification criteria:

- 1) hold at minimum a doctoral degree,
- 2) have relevant scientific achievements,
- 3) take an active part in scientific life.

The ideal candidate should meet the following criteria:

1. is a scientist with a doctoral degree in the field of sociological or related sciences, cooperating with PRAs (Priority Research Areas) (https://futuresoc.id.uj.edu.pl/en_GB/about-us),
2. has international experience, defined in particular as an academic degree obtained at a recognized foreign research center in the field of sociological or related sciences, or a postdoctoral fellowship completed at a recognized foreign research center, or as past employment in an international research project,
3. is the author of at **least two publications** in at least one of the research areas listed in the call (described below), which:
 - a. are published in high-IF journals included in Scopus (in particular Scopus Top 10) or Web of Science, or
 - b. are peer-reviewed scientific monographs published by an entity from the 2nd level of the Ministry of Education and Science (<https://listymnisw.pl/full.php>) list of publishers that publish reviewed scientific monographs, or
 - c. constitute a chapter in a multi-author publication published by a publisher from the 2nd level of the Ministry of Education and Science (<https://listymnisw.pl/full.php>) list.

In the case of publications referred to in items a) and b) above, the candidate's co-authorship will also be recognized.

4. has experience in managing an ongoing or completed research project financed from external sources or has been the main contractor or co-contractor of at least one completed or ongoing research project financed from external sources,
5. has documented experience in conducting empirical research (qualitative and / or quantitative; experience with digital methods of social research is considered to be an additional benefit),
6. has knowledge of English, at least at the C1 level (in accordance with the Council of Europe Level: Common European Framework of Reference for Languages), documented by appropriate certificates or experience (interviews with the candidate will be conducted in English),
7. is a member of a recognized international research network; in particular: belongs to the boards and committees of such organizations,
8. has experience in popularizing science and innovative education,
9. has experience in cooperation within the socio-economic environment.

Expectations:

1. implementation of a research project, in cooperation with stakeholders of the Lab,
2. submitting two publications to high-scoring journals (minimum 100 points) from Scopus TOP 10 or a monograph at an international publisher from the 2nd level of the Ministry Education and Science (<https://listymnisw.pl/full.php>) list, prepared independently or in cooperation (but with first authorship), affiliated at the Institute of Sociology of the Jagiellonian University, in a social science journal. Implementation period: by the 27th month of employment,
3. submission of a research grant to an external institution (by the 24th month of employment),
4. involvement in and for the benefit of the Social (r)Evolution Lab and the Society of the Future PRA, as well as building and strengthening interdisciplinary research and a network for the exchange of ideas within these structures,
5. representing the University and popularizing science, in particular the research conducted within the Excellence Initiative — Research University program.

Responsibilities:

The candidate will receive access to a research fund financed by the Social (r)Evolution Lab, as part of which the candidate will implement **a research project** on the sources, models, dynamics, and the consequences of contemporary processes of social change which aim to capture the emerging and colliding visions and projects of the society of the future. The project should concern one of the following research areas:

- I. social and political responses to changes, crises, and threats (economic, environmental, epidemiological, terrorist, etc.), with particular emphasis on social resilience, the role of the state and its institutions, self-organization, and the emergence of new forms of community,
- II. transformations of the public sphere, political cultures and ideologies, including the dynamics of power relations, relations between the state and the citizen, processes of democratization and authoritarianism, extremism, and populisms,
- III. social contexts, effects and challenges of the development of science and technology, e.g. with respect to work, personal life, consumption patterns, family, and kinship.

The project should clearly relate to selected research topics set out above, display a conceptualization of the research problem, a presentation of research questions, an outline of the methodology and justification of the project in terms of the implementation of the 4I principle (interdisciplinarity, internationalization, integration, innovation).

We offer:

1. The offered remuneration includes base salary and an allowance.
2. A fixed-term employment contract of 30 months.
3. Individual access to the research fund within the Social (r)Evolution Lab and coordinated by the person managing the Lab (in the amount of PLN 100,00000 for a period of up to 30 months) for the implementation of research and scientific activities. Funds will be distributed on the basis of research plans and planned budget prepared by the employee for a period of 12 months. Costs eligible under the fund may include, in particular: conference trips, implementation of pilot studies, visits for inquiries or short-term internships, publication costs, costs of organizing seminars / workshops aimed at strengthening foreign cooperation.

3. a copy of the doctoral or habilitation diploma, if applicable,
4. information on the candidate's research, teaching, and organizational achievements,
5. a list of publications (including the publisher and number of pages),
6. reviews of a doctoral dissertation or habilitation thesis, if applicable,
7. sample scientific publications in English (up to a maximum five),
8. two recommendation letters from two scientists with whom the candidate has cooperated previously,
9. a research project (a description of 5-6 standard pages in Polish or English and an abstract — max. 1 page, according to the template available at <https://futuresoc.id.uj.edu.pl/socrevlab>),
10. a completed personal information form concerning the applicant,
11. a declaration that the Jagiellonian University will be the primary place of work in the event of the candidate being employed,
12. a representation pursuant to Article 113 of the Law on Higher Education and Science,
13. a declaration of the knowledge and acceptance of the principles of intellectual property management and the principles of commercialization of the Jagiellonian University,
14. information on the processing of personal data.

Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

2. The Jagiellonian University appointed the Data Protection Officer www.iod.uj.edu.pl, Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: iod@uj.edu.pl or at the telephone number 12 663 12 25.
3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the attached advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the attached advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
