DESCRIPTION (field, expectations, comments, requirements):

Candidates are invited for a two-year Research/Teaching Fellowship at the Environmental Physics Group of the Department of Applied Nuclear Physics. The Fellow will participate in interdisciplinary research on the terrestrial environment performed in the framework of national and international research projects. A detailed research programme will be defined with the employed candidate, taking into account her/his experience and predispositions. The Fellow will teach, according to her/his competences, in the fields of physics, environmental physics, environmental chemistry, analytical methods, modelling of environmental processes, remote sensing or related areas.

The two-year Fellowship starts on the 1st October 2021

REQUIREMENTS

- PhD in physics, environmental sciences or environmental engineering.
- Experience and scientific achievements in at least one of fields:
 - application of physical and chemical methods in environmental research,
 - application of remote sensing in environmental research,
- Active participation in scientific conferences.
- Experience in computer programming in at least one of the following languages: MATLAB, Python, R.
- Predispositions and predilections for teaching.
- Knowledge of English (B2 level at least)
