Vice-Rector in charge of the School of Social Sciences at the Adam Mickiewicz University, Poznan announces a competition for the position of Assistant Professor (adjunct) at the Faculty of Sociology, Department of Research on Social Problems and Social Work.

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2021, item 478, i.e. Article 113) and who meet the following requirements:

- 1. Obtained a Master's Degree in one of the following disciplines: social work, education, sociology.
- 2. Obtained a PhD in one of the fields of social sciences, sociology or sociological sciences.
- 3. A proven track record of academic activity and publications in scientific journals recognised by the Polish Ministry of Education and Science on at least one of the following topics: social problems, social welfare, social policy, social work, social communication.
- 4. Participation in grants and research projects. Experience in conducting sociological research and analyses.
- 5. Proven active participation in conferences as well as organising of co-organising academic conferences.
- 6. Documented experience in cooperation with institutions and organizations working in at least one of the following areas: social work, pedagogy, social policy, social assistance, social support, educational institutions.
- 7. Documented experience in academic teaching of at least 400 conducted teaching hours, including the necessary experience in the core subjects for social work education.

- 8. Ability to conduct lectures and other types of teaching in English concerning courses taught at social work or sociology.
- 9. Proven experience running training sessions/workshops on social problems, social assistance and cognate areas.
- 10. Fluent command in speech and writing of Polish.
- 11. Knowledge of one of the conference languages (preference for English).

- 5. conference papers in Polish and other languages,
- 6. participation in grants and / or research projects,
- 7. cooperation with aid institutions and organizations operating in at least one of the areas, such as: social work, social policy, social support, educational institutions,
- 8. academic experience in teaching.

#### VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
