DESCRIPTION (field, expectations, comments, requirements):

Due to the expected source of funding for full-time employment, the Candidate for the position of Professor of AGH-UST, in the group of research workers should conduct research abroad for the last 5 years and not be in Poland during this period. In addition, the Candidate is required to:

- postdoctoral degree in Earth Sciences, in the discipline of geology or related, or a Ph.D. in Earth Sciences, in the discipline of geology or related (in the case of a person who at least the last 5 years was employed as a Professor position in a research units abroad),
- significant global scientific achievements in the fields of geology, hydrogeochemistry, the use of renewable energy sources, confirmed by high bibliometric indicators, and publications with a high impact factor (IF),
- documented significant achievements as a result of international cooperation,
- documented experience of managing international research teams,
- recognition and work experience in an international scientific environment (e.g. committees/colleges of international organizations, editorial boards of journals from the JCR list, etc.),
- knowledge of at least 2 foreign (congress) languages confirmed, working language in a third language is desired,
- documented achievements in the education of research staff,

DOCUMENTS REQUIRED

- application, CV, personal questionnaire,
- a copy of the postdoctoral degree diploma or doctor diploma (in the case of a person who at least the last 5 years was employed as a Professor position in a research units abroad),
- list of scientific publications with bibliometric data in which the Candidate was the main author or corresponding author, functions held in scientific or technical organizations,

- information about scientific achievements, international cooperation,
- confirmation or declaration of knowledge of at least 2 foreign (congress) languages,
- list of finalized doctoral dissertations in which the Candidate served as the supervisor and in which is the supervisor.

Achievements that are the basis for applying for the above-mentioned position, have to be obtained after conferring the academic degree of doctor.
