**within the research project titled “Private Law of Data: Concepts, Practices, Principles & Politics,”  
financed through the “POLS” grant**

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.4) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 166 of the Statute of the Jagiellonian University:

- 1) Holding at least a Master’s degree, Master of Science degree or an equivalent degree;
- 2) Exhibiting aptitude for research work;

Additional criteria:

1. Fluent English
2. At least intermediary Polish (ability to speak, read and write)
3. Research interest in the intersection of private law, or personal data protection law, and new technologies.

Candidates fulfilling one or more of the following criteria will be preferred:

1. A degree in law, or one of the project-related fields: philosophy, politics, sociology, psychology, marketing, informatics/computer science, or data analytics;
2. Experience in academic/scholarly work;
3. Practical experience in law, or data analytics, data-driven marketing, design of online services, or natural language processing;
4. International academic experience (fellowships, academic visits, Erasmus or other exchanges, international diploma, etc.)
5. Prior engagement in student organisations (academic associations, self-government, etc.).

1. application form;
2. resume;
3. personal questionnaire filled in by the candidate;
4. copy of the master’s diploma or a doctoral diploma, if applicable;
5. information on the candidate’s scientific, teaching and organisational achievements;
6. list of publications (along with the respective publishing houses and the number of pages), if applicable;
7. latest performance evaluation form, if the candidate was subject to such evaluation;

8. recommendation concerning the candidate's ability to work as an academic teacher, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation, as well as recommendation concerning the candidate's scientific work;
9. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
10. declaration under Article 113 of the Law on Higher Education and Science;
11. declaration on acknowledging and accepting the rules and regulations concerning intellectual property management and commercialisation in force at the Jagiellonian University;
12. information regarding processing of personal data;

Additional documents:

1. A short essay, between 500-1000 words, answering the questions: "What and why interests you at the intersection of law and new technologies?" The essay will be used to assess the fit for the project, as well as the ability for innovative and critical thinking.

**Application submission deadline: November 2, 2021**

The competitive selection process will be concluded by November 30, 2021.

A part of the recruitment process will be an interview. The Committee reserves a right to invite only selected candidates for the interview. The interviews will take place on November 5, 5, 8, 9, 10, 12 or 15, 2021.

### Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

1. The Administrator of your personal data is the Jagiellonian University with its registered office in Gołębia 24, 31-007 Kraków, represented by the Rector of UJ.
2. The Jagiellonian University appointed the Data Protection Officer [www.iod.uj.edu.pl](http://www.iod.uj.edu.pl), Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: [iod@uj.edu.pl](mailto:iod@uj.edu.pl) or at the telephone number 12 663 12 25.
3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the advertisement above – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the advertisement above based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal. 8. Your personal data will not be subject to automated decision making or profiling.
9. You have the right to lodge a complaint with the Inspector General for the Protection of Personal Data, if you feel that the processing of your personal data violates the GDPR regulations.
