III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2021, item 478, i.e. Article 113 as amended) and who meet the following requirements:

- 1. Completed studies in the field of film studies (bachelor's and / or master's studies), doctoral degree in the humanities in the field of literature or art studies.
- 2. Documented scientific, didactic and organizational achievements.
- 3. Fluency in the English language enabling conducting classes for foreign students.

In justified cases, the committee reserves the right to request additional external reviews of the candidates' achievements and / or additional documents to assess the candidates' qualifications.

VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage (from among persons meeting the formal requirements).
- 5. Interviews for candidates who meet the formal requirements. During the interview, the candidate may be asked to answer 1 question in English.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The Commission may ask for additional documents.
- 8. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.

IX) Prospects for professional development

Employment in one of the best Polish institutes focused on film and game studies is an optimal path of development for a scholar. An assistant professor is in constant contact with all research and didactic employees at the Faculty of Polish and Classical Philology, participates in the academic life of the Faculty, Institutes and Departments. The employee has a possibility to work in research teams and consult the progress of their own research at scientific meetings and conferences organized at the Institute of Film, Media and Audiovisual Arts and at other institutes. The assistant professor can be supported with the preparation and administration of research grant projects, may apply for funding or cofunding of their own research publications and participation in domestic as well as international conferences. They may also undertake research initiatives on their own and organize scientific conferences. The newly employed assistant professor is expected to receive a post-doctoral degree and become a professor. All together: research, teaching and organizational work at the Institute of Film, Media and Audiovisual Arts enable to get the necessary competencies, achievements, experience and authority to begin making efforts to obtain the degree of professor. The habilitation procedure is fully financed by the Faculty of Polish and Classical Philology.
