Centre for Evaluation and Analysis of Public Policies of the Jagiellonian University announces a competitive selection process for a scholarship for a student in an international, cross-disciplinary research project "City&Co: Older Adults Co-Creating a Sustainable Age-friendly City" financed by Program ENUTC: ERA-NET Urban Transformation Capacities of the National Science Centre.

Research will be conducted by the scientists from the Netherlands, Poland and Romania, focusing on the four cities: Hague, Wroclaw, Cracow and Bucharest.

The Polish Team consists of the Jagiellonian University in Cracow (Project Leader: dr hab. Jolanta Perek—Białas, prof. UJ) and a team of scientists from Wroclaw University of Environmental and Life Sciences leaded by dr hab. inż. Jan Kazak, prof. UPWr from the Institute of Spatial Management.

Participation in the project entitles to a **scholarship in the amount of 1500 PLN / per month** for the entire project duration. Competitive selection process, duration of the scholarship entitlement, as well as the participation in the project will be implemented according to "Terms and conditions of granting the scientific scholarships financed by National Science Centre" - Attachment to the Resolution of the Council No 25/2019 from March 14, 2019.

The Scholarship is financed by National Science Centre by Program EN-UTC ERA-NET Urban Transformation Capacities, financial agreement No UMO-2021/03/Y/HS6/00213.

Scope of the research activities planned in the project: cooperation in the scientific research and preparation of the analysis, conducting interviews, analysing the data from the research, cooperation with gathering the data to geoportal, cooperation with project partners.

Bachelor or Master's students (first-cycle and second-cycle students) are welcomed to participate in the competitive selection process.

Candidate's requirements:

- 1. Interest in the project subject matter
- 2. Very good work organization, reliability, and punctuality, ability to work in a cross-disciplinary team,
- 3. Excellent communication skills,
- 4. Fluent English,
- 5. Knowledge of MS Office Package.

Additional requirements:

- Ability to work in a team
- Very good work organization skills
- Excellent communication skills and manners

Additional candidate's assets:

- Interests in the fields of research and activities of Centre for Evaluation and Analysis of Public Policies,
- Experience in realization of quantitative or/and qualitative research methods, confirmation of achievements and additional scientific activities during the course of studies (participation in the research projects, being active in the Student's Scientific Associations,
- Experience in the research projects and preparation of the research reports.

Assessment criteria for granting the scholarship:

- Scientific achievements of the candidate, including publications and scientific presentations,
- Awards, scholarships and the research expertise gained outside the primary scientific institution in Poland and abroad,
- Competences to implement the activities included in the research project.

Personal data processing information for job applicants

- b. conduct recruitment process for the position specified in the advertisement for the **post of a Student in the research project "City&Co: Older Adults Co-Creating a Sustainable Age-friendly City"** based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). - 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.

If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
