We are looking for a post-doc to work in the research project funded by the National Science Center, Poland (OPUS 21): "Institutions as believers", PSP K/PBO/000871. The Principal Investigator is dr hab. Krzysztof Pośłajko.

The competitive selection process is open for all individuals, who meet the requirements set out in Articles 113 and 116.2.3) of the Act of 20 July 2018 – Law on Higher Education and Science, and who meet the following eligibility criteria according to § 165 of the Statute of the Jagiellonian University:

1. Holding at least a doctoral degree;
2. Having relevant scientific achievements;
3. Taking active part in scientific life;
4. Having experience in teaching work – this requirement does not apply to candidates for positions in the the research staff member group.

An ideal candidate should meet the following criteria:

1. strong theoretical background in social ontology and metaphysics of law;
2. knowledge of the basic issues in the contemporary debates on collective intentionality;
3. promising publishing record
4. willingness to work in a team.

Additionally, the candidate must meet the criteria of the National Science Center regarding post-docs in the OPUS 20 projects (Regulations on awarding funding for research tasks funded by the National Science Centre: [https://www.ncn.gov.pl/sites/default/files/pliki/uchwaly-rady/2021/uchwala12\\_2021-zal1\\_ang.pdf](https://www.ncn.gov.pl/sites/default/files/pliki/uchwaly-rady/2021/uchwala12_2021-zal1_ang.pdf)), which include:

1. they did not have the principal investigator as their research supervisor or auxiliary supervisor of their PhD dissertation.
2. their PhD degree has been awarded by another institution than the one planned to employ them at this post or they have completed a continuous and evidenced post-doctoral fellowship of at least 10 months in another institution than the host institution for the project and in another country than the one in which they have been conferred a PhD degree.

The contract will last for 30 months.

7. doctoral dissertation or habilitation dissertation review, if applicable;
8. latest performance evaluation form, if the candidate was subject to such evaluation;
9. recommendation concerning the candidate's research and teaching work, issued by the director of the organisational unit or a scientific supervisor, including the results of student surveys and evaluations, if the candidate was subject to such evaluation;
10. declaration of the candidate, confirming that the Jagiellonian University will be their primary place of work, should they be selected in the competitive selection process;
11. declaration under Article 113 of the Law on Higher Education and Science;
12. declaration on acknowledging and accepting the rules and regulations concerning intellectual

property management and commercialisation in force at the Jagiellonian University;  
13. information regarding processing of personal data;

## Personal data processing information for job applicants

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – hereinafter GDPR), the Jagiellonian University informs that:

1. The Administrator of your personal data is the Jagiellonian University with its registered office in Gołębia 24, 31-007 Kraków, represented by the Rector of UJ.
2. The Jagiellonian University appointed the Data Protection Officer [www.iod.uj.edu.pl](http://www.iod.uj.edu.pl), Gołębia 24, 30-007 Kraków. The Officer can be contacted by email: [iod@uj.edu.pl](mailto:iod@uj.edu.pl) or at the telephone number 12 663 12 25.
3. Your personal data will be processed in order to:
  - a. conduct recruitment process for the position specified in the above advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
  - b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide your personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing – on the terms and conditions set out in the GDPR.
7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
