- has in the scientific achievements at least a series of thematically related scientific publications published in reputable scientific journals or in peer-reviewed materials from international conferences or a scientific monograph or chapter in a book on the use of carbon isotopes to study environmental changes and radiocarbon dating,
- has the Hirsch index (without self-citations) at least  $h=10$ ,
- has significant global scientific achievements implemented in cooperation with more than one university or scientific institution, in particular foreign ones, in the field of dating with isotope methods, optimization of measurement methods, development of measurement data,
- has long-term experience in working in the accelerator mass spectrometry laboratory,
- has an experience in cooperation and managing national and international research teams,
- completed foreign research internship in a reputable radiocarbon laboratory,
- documented active participation in international conferences and symposia, participation in the organizational and scientific committees of national and international scientific conferences is welcome,
- has teamwork and communication skills, efficiency, good organization of work,
- obtained a very good periodic assessment or a very good opinion from the previous workplace, taking into account the candidate's scientific achievements.

You may be a person who meets the following requirements set out in the Law on Higher Education:

- has the qualifications specified in the Act,
- has full legal capacity,
- has not been punished by a final judicial decision for an intentional offence,
- fully enjoys public rights.

4. candidates who are not Polish citizens - a certificate of knowledge of the Polish language at a level of at least C1.
