DESCRIPTION (field, expectations, comments, requirements):

Theme: The main tasks of the offered position concern the improvement of the research work conducted in the Department in the field of vitreous/ceramic and composite biomaterials including: development of new functional glasses, glassceramics as well as composites on ceramic/metallic/polymer matrices.

Responsibilities: Development of modern preparation techniques (e.g. electrospinning, incremental techniques) and use of advanced research methods for materials characterisation. Acquisition of funds for research from national (NCN/NCBiR) and international sources. Active cooperation with scientific partners from both national and foreign centres. High publication activity, presentation of research in the international scientific community.

Requirements: PhD degree in engineering sciences in the discipline of materials engineering or chemical engineering, extensive knowledge in the field of biomaterials, knowledge of issues related to complex materials characterisation, including biological study of biomaterials in vitro, , at least 4 years of research experience, including at least 3 years of experience in a research institute other than AGH, involving independent research, management and participation in national and international collaborative research projects, considerable scientific achievements, including at least 25 publications in journals listed in the Journal Citation Reports database with the total IF value  $\geq 100$ , Hirsch Index  $\geq 10$ , scientific activity conducted in cooperation with other research centres (at least 3-months internship), active participation in conferences and symposia, knowledge of spoken and written English at the level of at least B2, very good organisation of own work, communicativeness and ability to work in a team.

The candidate must fulfil the following requirements defined in the Polish Law on Higher Education:

- possesses qualifications defined in the Law,
- has full legal capacity,
- has not been punished by final court judgement for intentional offence,
- enjoys full public rights.
