Associate Professor at the Department of Logistics**

Candidates must meet the requirements set out in Art. 113 and Art. 119 paragraph. 1 of the Polish Law on Higher Education and Science of 20th July 2018 (Journal of Laws 2021, item 478, as amended), hereinafter the Act.

Formal requirements:

Candidates should have:

- academic title / academic degree / professional title, professor in the field of management and quality sciences or economics and finance
- specialist preparation and experience in conducting classes in the following subjects:
 1. management of a transport company
 2. systems engineering and system analysis,
 3. standardization and quality management in logistics,
 4. production logistics,
 5. supply logistics,
 6. distribution logistics,

Candidates should submit a declaration of compliance with the requirements specified in Art. 113 of the Act.

Candidates should have professional experience and competences obtained outside the university, allowing for the proper implementation of classes within the study program.

Candidates applying for the position should submit the following documents within the deadlines set in this announcement:

1. A signed application
2. Personal data form for an employment applicant
3. Confirmed copies of documents confirming obtaining the academic title, academic degree, professional title or equivalent.
4. Information on research and teaching achievements and / or description of practical experience gained outside higher education, with particular emphasis on the scientific discipline related to the announcement stated in the competition.
5. The candidate's declaration that he or she agrees to be employed full-time and that the university will be the core place of work (in case of a candidate applying for full-time employment).
6. GDPR statement.
7. Statement on professional experience and competences obtained outside the university, allowing for the proper implementation of classes within the study program.

The candidate may submit:

- other documents or provide information which he believes may be useful in the settlement of the competition, regarding, for example, teaching qualifications, documents confirming experience in conducting research and development works or to declare about the readiness to carry out this type of work for the university.

The Competition Board Members may ask the candidate to submit a reference or invite for an additional interview.

The submitted copies of documents must be provided with a candidate's clause confirming their compliance with the original version of the documents.
