- experience in conducting Polish and English didactic classes,
- knowledge of English (in speech and writing) at level B-2,
- exploitation licenses for devices, installations and power networks with a voltage of up to 1 kV,
- knowledge of MS Office, MATLAB, Simulink and LTSpice,
- the skill of programming microprocessors in C/C++ and using Simulink,
- knowledge of the basics of FPGA programming in VHDL,
- one of the following conditions fulfilled:
 - 1) is a participant in doctoral studies and has a doctoral dissertation initiated,
 - 2) is a doctoral student at a doctoral school after a positive mid-term evaluation and completed modules preparing for work as an academic teacher provided for in the doctoral school education program,
