Rector - Commander of the General Tadeusz Kościuszko Military University of Land Forces (MULF) announces a competition for the position of Lecturer in the group of teaching staff at the Physical Education and Sport Department of MULF.

Working time: full-time - employment contract from 01.10.2022 r.

Place of work:

The General Tadeusz Kościuszko Military University of Land Forces, ul. Piotra Czajkowskiego 109, Wrocław.

The scope of the main tasks performed at the workplace:

- preparation and conducting of didactic classes in accordance with the accepted standards, curricula, study plan and timetable, within the prescribed period of time;
- participation in various forms of education as well as preparation and implementation of credits and consultations;
- participation in the preparation and conduct of entrance exams in the recruitment process;
- improving teaching and methodological qualifications;
- development of planning and analytical materials and reports on teaching activities;
- participation in the work of committees established at the University level in order to secure its activities;
- cooperation with other employees in developing and updating study plans and curricula as part of the subjects carried out at MULF;
- performing other duties resulting from the orders of superiors, which are substantively related to the position held.

Necessary requirements for the job position:

- completed 1st and 2nd degree studies or uniform master's studies in physical education
- having instructor / coaching / in sports disciplines useful in military training / close contact combat, boxing, judo, gymnastics /;
- declaration (declaration) full-time at MULF as the primary workplace;
- declaration (declaration) of participation in organizational projects carried out by MULF;
- having substantive competences in the scope of conducting classes with university students in subjects related to physical education, physical recreation and sport;
- availability, communication, responsibility and independence;
- the candidate who was selected in the recruitment process submits a declaration that during employment he undertakes to inform the employer in writing each time about:





- intention to leave and stay abroad,
- the name of the employer with which he performs paid work and the address of his seat.

Additional competences appreciated:

- having substantive competences in the field of sports training with university students;
- ability to work in task teams.

- a statement that the candidate complies with the requirements referred to in Art. 20 sec. 1 points 1-3 of the Act of 20 July 2018 The Law on Higher Education and Science (Dz.U. 2021 position 478) and that the candidate has not been punished with a disciplinary penalty as referred to in Art. 276 sec. 1 points 7 and 8 of the Act,
- if the documents are not issued in Polish, it is necessary to submit a copy of the documents together with a sworn translation, if the academic title was obtained at a foreign University, it is necessary to submit a copy of a document confirming the recognition of the academic title or a declaration as to the basis for recognition of the title on the basis of an agreement on recognition of the equivalence of education in Poland),
- declaration of undergoing the examination procedure (applicable to candidates who are not Polish citizens).
