# The Competition for the position of University Professor

The Rector – Commandant of the General Tadeusz Kościuszko Military University of Land Forces announces a competition for the position university professor of University Professor at the Faculty of Security Studies in the group of research and teaching teachers.

**Job status:** full-time employment contract, from 1 October 2022.

<u>Place of work:</u> The General Tadeusz Kościuszko Military University of Land Forces, Piotra Czajkowskiego Street No. 109, Wrocław, Poland.

## **Main duties will include:**

- preparing and conducting didactic classes in accordance with the accepted standards, curricula, study plan and timetable, as part of the planned number of classes specified in the AWL work regulations;
- participating in various forms of education, preparing and implementing of course credits as well as conducting consultations with students;
- participating in preparing and conducting diploma exams;
- conducting diploma theses;
- acting as a promoter and reviewer in doctoral dissertations;
- supervising PhD candidates in accordance with procedures related to doctoral proceedings;
- preparing and maintaining didactic and methodological documents;
- leading scientific and organizational projects implemented by AWL;
- conducting journalistic activities in the field of scientific research;
- developing planning and analytical materials as well as reports on conducted research and teaching activities;
- analyzing education and training programs in the field of subjects conducted and developing proposals for their changes, taking into account the current needs and conclusions from the audit activity;
- participating in the commissions and in the recruitment process at the University;
- using the IT system supporting the University management process in the area of planning, recording and accounting for the teaching process as well as the document workflow within own competence.

## Job related requirements to be met:

- having the academic degree of habilitated doctor in the field of social sciences in the discipline of legal science;
- scientific and journalistic achievements in the discipline of security sciences or defense science;
- having professional experience and substantive competence in conducting classes with university students in related subjects with Basics of civil and labor law, selected elements of military law, basics of international law, administrative law, legal bases of security;





- experience in conducting doctoral dissertations;
- a declaration of full-time employment at MULF as the main place of work;
- computer skills (MS Office).

### Additional competences welcome:

- membership in scientific societies, editorial boards of journals and scientific committees research at the national and international level:
- significant achievements in national and international cooperation;
- experience in acquiring and implementing of research projects and scientific grants;
- teaching experience in English (candidate's declaration);

- in the case of candidacy of foreigners whose documents are not issued in Polish, it is necessary to submit copies of the documents together with a sworn translation;
- if the title / academic degree was obtained at a foreign university, a copy of the document confirming the nostrification of the title / academic degree should be submitted (if required by law) or a statement as to the basis for the recognition of the title / degree on the basis of the agreement on recognition of equivalent education in Poland;
- for candidates who are not Polish citizens a declaration about undergoing the examination procedure is required.

The above documents should be delivered to MULF in a sealed envelope with the name of the position or via e-mail.
