

# Competition for the position OF THE UNIVERSITY PROFESSOR on the Faculty of Management, MULF

Rector-Commandant of the General Tadeusz Kościuszko Military University of Land Forces calls for the competition for the position of the **University Professor** (a group of research and teaching staff) on the Faculty of Management, MULF

Working time: full, employment contract from October 2022.

<u>Place of the work:</u> General Tadeusz Kościuszko Military University of Land Forces, ul. Piotra Czajkowskiego 109, Wrocław

## The scope of the main tasks performed at the workplace:

- Conducting teaching activities with training groups in accordance with the study plan, curriculum and schedule within the framework of the stipulated salary;
- Participation in various forms of education and preparation and implementation of credits and consultations;
- Participation in the preparation and conduct of diploma examinations;
- Cooperation with other employees of the Institute of Management in developing and updating study plans and curricula for the subjects taught at the Faculty of Management;
- Improving teaching and methodological qualifications;
- Participation in research teams and conducting scientific and research work;
- participation in seminars, symposia and scientific conferences organized by military and civilian universities;
- conducting journalistic activities (textbooks, scripts, methodological studies, articles, etc.);
- Participation in the work of committees established at the level of the University to secure its activities;
- Preparing and maintaining required teaching and methodological documentation in accordance with applicable standards;
- conducting teaching activities in accordance with accepted standards and educational programs;
- performance of other duties resulting from the orders of superiors, substantively related to the position.

#### Requirements to meet related to the job:

- Possession of a doctoral degree in the discipline of sciences management and quality sciences:
- significant scientific and teaching achievements in the field of management;
- declaration of full-time employment at AWL as the primary place of work;
- possession of substantive competence in teaching management-related subjects to university students (copies of diplomas, certificates, attestations);
- Declaration of participation in scientific and organizational projects implemented by AWL (candidate's statement);
- fluency in the Polish language;
- professional practice related to teaching;



- the candidate who is selected in the recruitment process shall make a declaration that during the course of employment he/she undertakes to inform the employer in writing each time of:
  - intention to go and stay abroad,
- the name of the employer where he/she performs gainful employment, and the address of its headquarters.

# **Additional competences:**

- Experience in teaching in English (candidate's statement);
- Commitment and creativity, conditioning an attractive course of classes;
- Availability, communication skills, responsibility and self-reliance;
- ability to work in task teams.

**Documents:** CV, cover letter, copies of documents confirming: education, work experience, completion of courses and training and other documents confirming qualifications, declaration of full-time employment at MULF, a statement that it meets the requirements referred to in art. 20 clause 1 points 1-3 and art. 276 paragraph 1 points 7 and 8 of the Act of 20 July Law on Higher Education and Science, in the case of candidacy of foreigners whose documents are not issued in Polish, it is necessary to submit copies of the documents together with a sworn translation; if the work title was obtained at a foreign university, a copy of the document confirming the nostrification of the title / academic title should be submitted (if required by law) or a statement as to the basis for the recognition of the title / degree on the basis of the agreement on recognition of equivalent education in Poland; a declaration is required for candidates who are not Polish citizens about undergoing the examination procedure.

The above documents should be delivered to MULF in a sealed envelope with the name of the position.

The University reserves the right to contact selected persons who meet the requirements specified in the announcement and to cancel the Competition without giving reasons.
