THE RECTOR of the Jagiellonian University announces a call for two positions of POSTDOCTORAL RESEARCHER in a group of researchers

at the Faculty of International and Political Studies

in the fields of political and administrative science, sociological science, in the thematic scope falling within the domains and research topics of the Strategy of Priority Research Area Anthropocen (Climate change - their determinants and consequences; Migration movements in the era of global changes; Globalization and Europeanization; Pandemics; Political, social, migration crises, armed conflicts).

The call is open to persons who meet the conditions set out in Article 113, 116 sec. 2 item 3 of the Act of 20 July 2018 — the Law on Higher Education and Science and, pursuant to Article 165 of the Statute of the Jagiellonian University, meet the following qualification criteria:

- 1) hold at minimum a doctoral degree,
- 2) take an active part in scientific life.
- 3) have relevant scientific achievements,

Ideally, the candidate should meet the following criteria:

- 1. experience in international cooperation, confirmed by the implementation of research projects and the implementation of foreign internships,
- 2. scientific achievements including international publications,
- 3. experience in organizational and project work (has been a project manager, main contractor, or co-contractor), in particular in the implementation of international projects financed using external sources,
- 4. documented fluency in English,
- 5. experience in popularizing science and innovative education,
- 6. establishment an interdisciplinary research team during employment,
- 7. submission of at minimum two publications to international high-scoring journals (IF) from the list of the Ministry of Education and Science,
- 8. preparation of a project application during employment for an international research grant, financed from external sources.

We offer:

- 1. The offered remuneration includes base salary and an allowance.
- 2. A fixed-term employment contract of 33 months.
- 3. The candidate will be granted access to the research fund for 33 months.

- 2. a resume containing information on completed education, internships, academic and non-university professional experience, language proficiency and other qualifications,
- 3. a copy of a doctoral diploma or a habilitation diploma, if applicable,
- 4. information on the candidate's research and organizational achievements,
- 5. a list of publications (including the publisher and number of pages) and conducted research grants,
- 6. reviews of a doctoral dissertation or habilitation thesis, if applicable,
- 7. a copy of a document of fluency in English (with the exception of people for whom English is the mother tongue or if the language of instruction during academic education was English).

- 8. A proposed research project devoted to one of the domains and research topics of the Strategy of Priority Research Area Anthropocene (Climate change their determinants and consequences; Migration movements in the era of global changes; Globalization and Europeanization; Pandemics; Political, social, migration crises, armed conflicts. Project description in English, up to 7 standard pages with a bibliography, including the description of: the purpose and significance of the scientific project, research methodology, innovative character, contribution to development research.
- 9. a completed personal information form concerning the applicant,
- 10. a declaration that the Jagiellonian University will be the primary place of work in the event of the candidate being employed,
- 11. a representation pursuant to Article 113 of the Law on Higher Education and Science,
- 12. a declaration of the knowledge and acceptance of the principles of intellectual property management and the principles of commercialization of the Jagiellonian University,
- 13. information on the processing of personal data.

Selected candidates will be invited to an online interview, during which the candidate will be asked to present a multimedia presentation on their proposal of a research project, concerning the research project, achievements and research plans as well as activities related to the implementation of the project, international cooperation and cooperation with the socio-economic environment.

Personal data processing information for job applicants

- 3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in the above advertisement as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in the above advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
- 4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide you personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
- 5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
- 6. You have the right of access to the content of your personal data, as well as the right to correct, delete, restrict processing, transfer, object to processing on the terms and conditions set out in the GDPR.
- 7. If the processing is based on consent, you have the right to withdraw the consent at any time, which shall not affect the lawfulness of processing based on the consent given before the withdrawal.
