

## **The competition for the post: lecturer**

The Rector – Commandant of General Tadeusz Kościuszko Military University of Land Forces announces a competition for the post of an lecturer (instructor) at the Faculty of Security Studies.

**Job status:** full-time contract of employment

**Place of work:**

The General Tadeusz Kościuszko Military University of Land Forces (MULF), ul. Piotra Czajkowskiego 109, Wrocław.

**Main task:**

- preparing and conducting didactic classes in accordance with accepted standards, educational program, study plan and timetable, as part of the planed teaching load;
- participation in various forms of education, preparing and leading (running) passes and consultations;
- developing (creating) educational and methodical documentation;
- developing planning and analytical documents, completing reports from educational activity;
- analyzing (studying) educational programs and trainings in the field of subjects (activities) and developing proposals for their changes included current needs and recommendations from control activity;
- handling of the elements of information system adjunctive in management process of university in the field of planning, inventorying and processing the educational process and documentation workflow in the field of competencies;
- participation in scientific and organizational projects realized by the MULF.

**Necessary requirments:**

- required education level: masters's degree;
- paramedical eligibility;
- a declaration of full-time employment at MULF as the main place of work;
- IT skills to include familiarity with Microsoft office suite and internet/ e mail.

The candidate who has been selected in the recruitment process submits a declaration that during employment he undertakes to inform the employer in writing each time about:

- intention to leave and stay abroad,
- the name of the employer with which he performs paid work and the address of his seat.

**Additional requirments:**

- experience in organizing first aid popularizing projects;
- completed courses of TCCC-MP (Tactical Combat Casualty Care for Medical Personel) or the international organization NAMIT;
- experience in conducting classes in the field of first aid or medical rescue;
- completed courses as first aid instructor, mountain rescuer and water rescuer;
- ability to work in a team.

**Documents:** CV, a motivational letter, copies of documents confirming education, seniority, completed courses and trainings as well as other documents confirming qualifications, scientific and didactic experience, a full-time job declaration at MULF as the main place of work (in case of foreign candidates if the documents are not issued in Polish, it is necessary to submit copies of documents together with a sworn translation; if the academic degree was obtained at a foreign university, a copy of the document confirming the recognition of the academic degree or a statement about the basis for recognizing the title on the basis of the agreement on the recognition of education equivalence in Poland should be submitted), a statement on submission to the examination procedure (applies to candidates who are not Polish citizens).

The above documents should be delivered to MULF in a sealed envelope with the name of the position or electronically.

**Please add the following clause:** “I have read the information clause, including the information about the purpose and methods of processing my personal data and my rights”.
