We are looking for teacher-researcher to be employed in the Department Applied Computer Science and Computational Physics. The selected candidate will participate in research in theoretical physics in the areas of activity of the Department (complex systems, solid state physics, nanostructures, elementary particle physics etc.). We are also open to extend the range of topics to the research in the area of interest of the candidate. The candidate will teach physics and programming in English and Polish. An extension of the contract to permanent position is possible. Candidates with habilitation will be promoted to the university professor position.

28-month contract starts on the 1st March 2023

REQUIREMENTS

- PhD in physics or a related discipline,
- Good scientific record,
- Independence in conducted research,
- Experience in teaching,
- Active participation in scientific conferences,
- Organizational experience,
- Readiness to teach courses in Polish and English. A good knowledge and readiness for teaching:
 - 1) programming in Java, Python, C++, C (at least three of the four);
 - 2) Unix system, computer networks (at least one of the two);
 - 3) data bases;
 - 4) physics.The candidate should fulfill at least three of four above conditions.
- Knowledge of English (B2 level at least),
- Knowledge of Polish B2 level at least (not required for candidates for whom Polish is the first language).
